## Commitment - We lead lives of purpose (I Peter 4:10).

I will use school technologies at appropriate times, in appropriate places, and for school-related work.
I will respect privacy and security of myself and others by not sharing private, sensitive, or confidential information
without prior authorization on websites, software, or in artificial intelligence (AI) or Natural Language Processing
(NLP) tools.
I will be stewardly using my gifts and managing resources to further God's kingdom recognizing that GRCS
technology use is a privilege and intended for school related purposes by:

- Taking responsible precautions to care for, maintain, and protect school technologies and promptly reporting any damage to technology staff.
- Keeping the school-issued device in a case, keeping liquids away from the device, and not adding to or removing device labels.

- Keeping my login information secure, and only sharing it with administration or technology staff upon request.
- Respecting the district network's security measures and not attempting to modify any restrictions or
  protections, not connecting unapproved devices to the GRCS network, and not downloading apps or
  content I don't have permission to access.
- Being stewardly with GRCS technology resources such as file storage capacity, printing, and not using programs/websites that negatively affect our bandwidth.
- Acknowledging that all electronic files stored on school resources, including emails, are the property of GRCS, and I am responsible for backing up my own files.
- Recognizing that the technology belongs to GRCS and should not be used to send unsolicited mailings, distribute destructive programs, play games, or for personal businesses.

Violating the <u>GRCS Responsible Use Policy</u> and this contract or having multiple incidents with the school-issued device may result in loss of take-home privileges, restrictions on device use, and/or other disciplinary actions.

My family is financially responsible for the replacement or repair costs if the school-issued device or accessories are lost, stolen, or sustain damage due to accident, neglect, or abuse following the guidelines in the incident policy as defined on the GRCS Instructional Technology website. Example costs:

- a. Loss or damaged power supply parts: Power adapter \$19; cable \$19.
- b. Replacement of broken or non-functioning parts such as a broken screen or iPad keyboard: Additional fee up to \$200.
- c. Replacement costs due to loss, theft (police report required), or excessive damage such as a liquid spill: Additional fee up to \$500.
